21st Annual

Russell H. Perry Award Dinner Honors Drayton McLane

allas Baptist University proudly named Drayton McLane as recipient of the 2008 Russell H. Perry Free Enterprise Award during the annual award dinner held on Novem-

ber 24 at the Hilton Anatole Hotel.

United States Senator Kay Bailey Hutchison served as the keynote speaker for the evening. Dr. Kenneth H. Cooper, founder and CEO of the Cooper Aerobics Center, and his wife, Millie, filling in for Julie Turner, were the honorary chairs of the dinner, which saw over 1,200 in attendance. J.L. Sonny Williams, a DBU alumnus and trustee and past president and COO of Minyard Food Stores, Inc., was this year's dinner chair and master of ceremonies.

The annual gala event marked its 21st anni-

versary as it continues to honor Texas leaders whose lives are testimonies of achievement in free enterprise and service to the community. The event is named in memory of Dallas leader and philanthropist Russell H. Perry, whose life of service to Dallas impacted many lives. Mrs. Russell H. (Phoebe) Perry continues to be a friend of the city of Dallas

Over the past 20 years, the dinner has honored many North Texas leaders, and in doing so, has raised over \$2.6 million in scholarship funds for over 1,100 DBU students. This year's selection of

Drayton McLane marks the first time the award has gone to an individual beyond the Dallas Metroplex.

Making a welcome return to the dinner was Dr. Gary Cook, president of DBU. On October 12, 2007, he was diagnosed with acute myelogenous leukemia and hospitalized, undergoing treatment and observation a total of 32 days

"Drayton McLane is a mentor, a friend, a good man," testified Pam Gardner, President of Business Operations for McLane's beloved Houston Astros. "He has a passion for everything he does, not just business and politics, but really for life. He is the energy and force behind any project that he touches."

At the conclusion of the video, Dr. Kenneth Cooper, honorary chair of the dinner, and his wife, Millie, came to the podium and formally presented the award to Drayton McLane—a man who has spent his whole life learning and growing in the business community, building several incredibly successful organizations along the way.

Raised by a father who managed a wholesale

grocery distribution center, Drayton was introduced to business at a young age. He began working for his father at age nine, soaking up knowledge of various aspects of the family company. After graduating high school in 1954, he ventured off to Baylor to earn his undergraduate education and then to Michigan State University to receive a Master of Business Administration degree in marketing. With five years of education and two degrees to his credit, he returned to work for his father. The following two and a half decades saw him serve as general manager of operations, president and CEO, and chairman of McLane Company. Having effectively created one of the largest distribution systems in the country, he proceeded to sell his business to Wal-Mart, becoming one of Wal-

The next major business opportunity that presented itself to McLane, the ownership of the Houston Astros, was a special challenge. McLane had little prior knowledge of baseball and had only attended a handful of professional games. Yet he eagerly took the reins in 1993 and, armed with his savvy business know how and Christian compassion, he has since transformed the Astros into a franchise which excels on the field and off the field, making a positive difference in the greater Houston community. In 2005, the Astros became the first Texas team to reach the World Series.

In addition to his leadership of the Astros, he devotes his time to the McLane Group, the family holding company for several U.S. and international corporations. Drayton and his wife, Elizabeth, reside in Temple and are active members of First Baptist Church in Temple. There, Mr. McLane serves as a deacon, having been a past chairman of the deacons, and has been a faithful Sunday School teacher for over 35 years. Additionally, he is very active in many local and national organizations, including the United Way and the Executive Committee of Boy Scouts of America and has served as Chairman of the Board for Scott & White Hospital, past Chairman and Board Member of Regents for Baylor University, and Board Member of the Cooper Institute. In addition, he owns Lone Star Plastics, Inc., in Garland, and Classic Foods in Fort Worth. The McLanes have two sons, Drayton III and Denton, and four grandchildren.
